

# **OUR CHALLENGE**


Old St. Mary Catholic Church was built in 1823; God's house, the oldest Catholic church here in New Hampshire! It is the foundation of our history, our first home and a source of pride for many who call St. Mary their home.

In 1870, we built anew on Central Street. For the past 150 years, it has served as the backdrop for so many of our gatherings and celebrations.. The years however have been unkind. Mother Nature was been relentless, renovations, modifications and repairs undertaken, and truth be told - mistakes were made (i.e. sandblasting the brick). All of these hardships and decisions have taken their toll on our beloved church and we are now called to return 'God's House, Our Home' back to its glorious condition.

After much prayerful study and discussion among the Staff, Finance Council and various professionals, it has been decided to undertake a parish-wide Capital Campaign to raise the funds necessary to improve our parish church and, if possible, address some other items as well.

# **Exterior Repairs & Restoration**

### **Church Steeple and Front Entry**

- Repair water damage and deterioration to steeple foundation
- Repoint brick (where needed), replace damaged brick and apply new coat of sealant
- Replace rotting wood trim and broken/missing/loose slate tiles
- Restore entrance door spires

### **East Wing Exterior and Roof Parapets**

- Address below grade drainage and roof level storm water runoff
- Replace roof parapet and coping stones (concrete edging along the roofline)
- Repoint brick (where needed), replace damaged brick and apply new coat of sealant

### North Elevation (Main St.)

- Repoint brick (where needed), replace damaged brick and apply new coat of sealant
- Install flashing on radial roof above sacristy and reseal exterior wall
- Replace missing/broken/loose slate tiles on roof
- Rebuild and reseal retaining wall
- Repair and repoint northwest chimney (northeast chimney repaired in 2019)

### **West Wing Exterior and Roof Parapets**

- Repair roof parapet and coping stones (concrete edging along the roofline)
- Repoint brick (where needed), replace damaged brick and apply new coat of sealant

#### Plaza

- Address drainage and storm water runoff
- Clean, repair and reseal plaza concrete

### Preliminary project construction budget: \$750,000



As we approach the 150th anniversary year of our current church, we have the unique opportunity to express our thanks to those who came before us, who nurtured our faith and who sacrificed to build what we have today. Likewise, we have the ability to prepare for the future so that our children and grandchildren can be provided for in faith, with a church and parish that is safe and secure.



#### **Need For Generosity**

The St. Mary community is looking to raise a minimum of \$750,000 through the efforts of this campaign. Every member of our parish community is integral to our success in reaching this goal, and, therefore, each family is asked to consider making a pledge to the campaign to the best of their ability.

Everyone is asked to prayerfully consider how their generosity can reflect their gratitude for the gifts that God has given them. We know that a sacrificial pledge will be a challenge for some of our parish households, therefore, it is vital to the success of our campaign that those who are able to make larger pledges do so.

Individuals who are financially capable of pledging \$10,000 \$25,000, \$50,000, or more, are asked to step forward and become leaders of our campaign. Please review the Suggested Gift Plans on the following page and choose a plan that is right for you and your family.

Each family is asked to consider a minimum pledge of \$4,000 or more, payable over three years. A pledge of \$4,000, after a down payment of \$400, is \$100 per month for three years or \$3.29 a day.

# **Giving Options**

**Pledges Via Cash, Check:** Simply complete your pledge card by selecting the amount of your pledge and down payment (optional, but encouraged). Make sure to select your method of payment, i.e., monthly, quarterly, or annual payments. Please make checks payable to **God's House, Our Home.** You will be mailed payment reminders and a special payment envelope in accordance with the payment plan you choose. Once completed, please return your pledge card in the weekly collection, bring it by the parish office or return it in the mail.

**Pledges Online:** Please complete your pledge card by checking the appropriate box to indicate that you wish to make your payments via electronic fund transfer from your bank account, debit or credit card. By choosing the electronic method of payment, you will need to set up the automatic payments on the parish website. Please visit **https://bit.ly/givetostmary** 


**Gifts of Stock:** Donors can use their own broker/agent or the parish agent to transfer stock. If the stock has been held long-term (over one year), the donor does not have to pay capital gains tax on the stock, and is allowed a tax deduction for the full value of the stock. Donors may also choose to sell stock in order to claim a loss, which may be beneficial for tax circumstances. In either case, the stock must first be transferred to the parish before being liquidated. Please contact the parish office for more information.

**Gifts from qualifying Retirement Accounts:** The IRA Charitable Rollover provision of the 2015 PATH (Protecting Americans from Tax Hikes) Act permits individuals age 70.5 or older to contribute up to \$100,000 each year tax-free from a qualifying IRA to charity, called a qualified charitable distribution (QCD). Additionally, the gift will count as your Required Minimum Distribution (RMD) but will not be included in your adjusted gross income. Please contact your financial advisor for additional information concerning gifts via qualified retirement accounts as these provisions continue to change year to year.

**Gifts of Property, Life Insurance, Annuities, Wills or Bequests:** There are different ways to support St. Mary Catholic Church both today and, in the years to come via planned giving. Families or individuals can make gifts of life insurance, estate bequests, annuities or charitable remainder trusts. For substantial gifts of property other than marketable securities, the IRS requires an appraisal. Please contact the parish office for more information.

Federal and state laws on income and inheritance taxes encourage charitable giving. It may be particularly advantageous for some people to contribute stocks, appreciated securities, annuities, property or other valuables. In many cases, the tax savings may be more than your original investment in the gift. Because each situation is unique, we urge you to discuss such donations with a financial advisor.
